TERMS AND CONDITIONS

WIN *one of two*

HOOGA *Outdoor Fireplaces*



Definitions:

In this document, the following words have the following meanings:

- A. "Eligible Entrant" means the registered owner of a Property within New Zealand that books an appraisal with PGWRE during the Promotional Period.
- B. "PGW" means PGG Wrightson Limited.
- C. "PGWRE" means PGG Wrightson Real Estate Limited.
- D. "Prize" means one of two HOOGA Outdoor fireplace to the value of \$5,000.
Two winners will be drawn (One from the North Island and one from the South Island)
Each winner can choose from one of two outdoor fireplaces options:
 - HOOGA Original, ideal for large rural properties.
 - HOOGA Grasshopper, suitable for lifestyle and larger residential.
- E. "Prize Draw" means the prize draw anticipated by these terms and conditions whereby an Eligible Entrant is randomly drawn as the winner of a Prize.
- F. "Promotion" means the promotion set out in these terms and conditions.
- G. "Promotional Period" means the period from 1 May 2026 to 31 July 2026.
- H. "Property" means a property within New Zealand that has a valid address.

Terms & Conditions:

1. To be eligible for the Prize Draw, an Eligible Entrant must book an appraisal of their property with PGWRE during the Promotional Period.
2. Eligible Entrants must book their appraisal using the online form available at <https://www.pggwre.co.nz/appraisal>.
3. There is a limit of one entry into the Prize Draw per Eligible Entrant e.g. even if an Eligible Entrant requests appraisals for multiple properties that they own, they will gain one entry into the Prize Draw.
4. If an Eligible Entrant cancels their appraisal before 31 July 2026 their entry into the Promotion and Prize Draw will be withdrawn.
5. A Property that has been appraised by PGWRE within the past 3 months (prior to 1 May 2026) is not eligible for entry into the Promotion.
6. The Prize Draw will be carried out on 3 August 2026 at PGW's head office, or any other locations determined by PGWRE. The winners will be contacted by a representative of PGWRE via the contact details supplied when booking the appraisal of their property. If a winner cannot be contacted by 13 August 2026 another winner will be drawn at random.
7. Each Prize will be delivered to the Mainfreight depot located closest to the address of each winner (as advised by each winner). PGWRE will pay for delivery to the Mainfreight depot. Each winner will be responsible for organising the collection (or delivery) of the Prize from the Mainfreight depot to their address at their cost.
8. Each Prize will need to be collected from the Mainfreight depot within 4 weeks of it being delivered to the Mainfreight depot. If a Prize is not collected the prize will be forfeited and another winner will be drawn at random.
9. An appraisal does not need to be completed during the Promotional Period, booking an appraisal enables entry into the Promotion.
10. Each winner of a Prize consent to PGWRE using their name, city of residence and/or photographs for promotional purposes in any media for an unlimited period without remuneration.
11. Decisions of PGWRE on all aspects of the Promotion and Prize Draw are final and no correspondence will be entered into. PGWRE reserves the right to modify, terminate, or change the promotion or any of the terms and conditions of the promotion at any time without notification.
12. Except for any liability that cannot be excluded by law PGW and PGWRE excludes all liability (including negligence), for any personal injury; or any loss of damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion and/or use of the Prize.
13. A winner of a Prize acknowledges that they will use the Prize in accordance with the manufacturer's instructions.
14. The terms and conditions of the Promotion are governed by New Zealand law, and any dispute arising out of or in connection with them will be subject to the exclusive jurisdiction of the New Zealand courts.
15. Employees of PGW, PGWRE and their immediate families, are not eligible to enter the Promotion.
